

Terms and Conditions of the Cashback Offer

1. The promoter is ScottishPower Energy Retail Limited (**the "Promoter"**), which has its registered office at 320 St.Vincent Street, Glasgow, G2 5AD
2. The promotion is the award of cashback in accordance with these terms and conditions to Qualifying Applicants (defined below) (**the "Promotion"**).
3. The Promotion will run for the period from 12:00 hours on 25th June 2018 until 17:00 hours on 17th July 2018 inclusive (**the "Promotion Period"**).
4. The Promotion is open to applicants who meet the following eligibility criteria ("**Qualifying Applicants**"): (1) are legal residents of Great Britain aged 18 years or over; (2) are returning ScottishPower customers that apply for one of our tariffs for supply of gas and/or electricity supply during the Promotion Period via the website at www.scottishpower.co.uk/ and (3) come on supply with ScottishPower with a gas and /or electricity supply.
5. The Promotion is not open to current customers of the Promoter or those who have applied for energy supply from the Promoter prior to the Promotion Period and are awaiting confirmation of their supply start date(s). Employees (or members of their immediate family) of the Promoter, its related companies, agents or anyone connected with this promotion are ineligible to participate.
6. The Promoter reserves the right to verify the eligibility of all entrants and has the right to reject any applications that appear to be duplicates, materially incorrect or fraudulent.
7. The Promoter will award Qualifying Applicants with cashback as follows:
 - a. the sum of £25 (twenty five pounds Sterling) where gas or electricity is supplied; or
 - b. the sum of £50 (fifty pounds Sterling) where both gas and electricity are supplied (**the "Cashback"**).
8. The Promoter will post a cheque to Qualifying Applicants at the address provided by the Qualifying Applicant on their most recent application for a ScottishPower tariff within 6-12 weeks of the Qualifying Applicant coming on supply with ScottishPower.
9. The Promoter accepts no responsibility for any inaccurate postal address information provided by the Qualifying Applicant which results in the cheque not being delivered in accordance with this paragraph 8.
10. Only one cheque will be provided per household.
11. The Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate any applicant or Qualifying Applicant or accept any responsibility or liability for any damage, loss, liabilities, personal injury or disappointment incurred or suffered by any applicant or Qualifying Applicant in connection with the Promotion except where it is caused by the negligence of the Promoter, its agents, or distributors or that of their employees.
12. The Promoter reserves the right to withdraw the offer or amend these terms and conditions at any time without prior notice, where it is required to do so as a result of circumstances outside of its control. No correspondence will be entered into.
13. Applicant's personal details may be used by the Promoter for the purpose of conducting the Promotion. The Promoter may disclose applicant's personal details to any third party it engages to assist it in conducting the Promotion.
